Maybe an email to general membership stating what our advocacy efforts landed us...below is where I'm at and maybe we need to get membership involved on this...they may have an idea on how to showcase this:

ATTENTION ALL MEMBERS or maybe call it like, "Environmental Spotlight,"

As many of you know the Environmental Committee was hard at work last year advocating for an achievable statewide engine rule in the State of New Mexico. Many advocacy groups provided commentary ranging in categories from environmental activism, other industry groups and additional oil and gas service companies.

A consortium comprised of Archrock, J-W Power Company, & CSI CompressCo sponsored the GCA Environmental Committee. As a group, with the help of Bracewell, LLP and Modrall Sperling we provided proposed amendments in the categories of emission standards of engines, monitoring requirements, pneumatic controllers, control devices, equipment leaks and fugitive monitoring, and several general standards. The GCA was the only advocacy group the New Mexico Environmental Department collaborated on emission standards, and we ultimately had a win for every amendment we provided. We were cited 52 times in the final ruling by the Environmental Improvement Board, second to only one other advocacy group. This is a huge win for all GCA members and a collective step toward a bright advocacy future for the GCA Environmental Committee.
